When you renew in 2017, you will receive thank you gifts, including free dance lessons, me for quite some time... A week later , I limped across a dance floor I didn't know how my injured spine, balance problem, and nerve-damaged feet would affect my ability to dance. We started with swing, and in ten minutes, I was enjoying music like never before. I was dancing, really dancing. We tried a rumba next, and I was hooked. I was falling in love with dancing ... ballroom dancing. That life-altering day was December 2, 2009. Because of dance, I have become physically stronger, lost twenty-five pounds, improved my posture and carriage, diminished my chronic pain, and bolstered my self-confidence. I still limp but not when dancing, something doctors are unable to explain. I'll never overcome my PTSD, but I have learned how to deal with it in ways that it doesn't interfere with my life as much as it once did. To a large degree, dancing has set me free and tamed the demons of traumas from my past."



When you choose Florida's "State of the Arts" license tag for your vehicle, all of the proceeds fund visual and performing arts programs (like ours) right here in Volusia County.

#### How much does it cost?

The first-time cost of a State of the Arts plate is \$32 in addition to your vehicle's normal registration fee at time of renewal.

Of that, \$20 is tax deductible. Future renewals are only \$22 each year in addition to the normal registration fee with \$20 again being tax deductible.

**To re-order:**At renewal, simply state you would like a "State of the Arts" plate and include a check for \$32 along with your renewal notice. or ...

**Visit your local tag office**, turn in your current plate and receive your new "Arts Plate" on the spot for \$32. Gift certificates for State of the Arts plates are also available at your local tag office and make great gifts that also help our community.
