## Chapter Members Help Raise \$221,000 for Alzheimer's Care

On May 5, 2018 at the Macon City Auditorium, members of USA Dance Greater Macon Chapter 6059 serving as "Pro" dancers paired with local "Stars" to show off their dancing skills and raise money for Alzheimer's research and care in the Alzheimer's Association, Georgia Chapter's Dancing Stars of Central Georgia.

Chapter members dancing included Daniel Boudreault, who danced with local artist and art broker Lori Mitchell in a sizzling Argentine tango to "Asi se baila el tango" by Veronica Verdier. Costumed as Batman and Catwoman, Daniel and Lori captivated the audience with their daring routine including a fearless neck drop that drew gasps from the audience.

Laura Thomason danced a cha-cha to "24K Magic" by Bruno Mars with professor and community organizer Chris Tsavatewa. Chris distinguished himself not only with his dancing but also with his glitter-decorated beard and purple hair. The glitter beard garnered an extra \$1500 in donations: first from people who wanted him to wear it, and then from people who wanted him to shave it.

This year's event raised a total of \$221,000, bringing to \$1.6 million the amount raised since Dancing Stars' inception in 2012. Funds raised by the event help the Georgia chapter provide education, support groups, referrals to services, a 24-hour helpline, and more.
