TIPS FOR SHOWCASE DANCERS

SCHEDULE:

5:00 -5:15 P.M. – Performer Check-in only – in auditorium lobby

5:15 Doors open for social dance admission; general dancing

6:15 – 6:40 Act I Performances (8) followed by general dancing

7:15 – 7:40 Act II Performances (8) followed by general dancing

8:15 – 8:40 Act III Performances (8) followed by general dancing

8:45 – 10:15 general dancing; 10:15 – 10:30 cleanup and good night!

See SHOWCASE INFORMATION sheet for general participation and admission information.

See Registration Forms for details on how to enter. *Please do not use previous years' forms!*

- *Only one pro-am duet per partnership will be registered.*
- *A Group must include at least four amateur dancers and at least one USA Dance member, or be coached/choreographed by a USA Dance member.*
- *There is **no grace period** for submitting music.*
- *Registration opens July 1. Please do not submit entries before that date.*

Register early! Registration closes August 7 or when 24 complete entries have been received.

Showcase performances are allowed in *any dance style*. You will be responsible for transporting any props required for your routine, on and off the floor. If your routine has any kind of staged entry or exit, make a note of it on your entry or follow-up by email to usadancela@gmail.com, no later than August 10.

If you want specifically to perform in Act I, II, or III you must state your preference on your registration. Scheduling requests will be accommodated if possible, but at the Registrar's discretion.

Please support your fellow performers with your attention and applause!

Show Day:

Wear your best and sparkliest dance attire! Costumes are not required, but are encouraged.

We encourage performers to arrive early to warm up before social dancing begins, and to secure your seats if you are not with a group. This year's event includes over three hours of social dancing, which will occur

before, after, and during the breaks between Acts. If you need to run your routine on the main floor before general dancing begins, please plan to arrive early so that we can check you in as fast as possible.

There will be dressing rooms backstage for men and women, with garment racks. Please mark your shoe bags, garment bags, etc with your initials or name, and keep a list of what you bring with you. Check your list before you leave to make sure you have all of your belongings. USA Dance assumes no responsibility for forgotten items.

Performers may pick up a complimentary bottle of water at check-in. There will be snacks served during the second period of social dancing. If you want to take some food backstage, you are welcome to. Please dispose of your own trash.

The order of performance will be determined and announced to performers, by email and on our website, by the Friday preceding show day.

You will be responsible for keeping track of which Act you are in, and being ready at least two numbers in advance of your own. If you are leading off a certain Act, please be ready five minutes ahead of time.

If you are not ready when called, you will be called once more and then the subsequent performer will be called. You will be asked to perform your number at the end of the Act in which it was scheduled, *or* in the subsequent Act.

There will be ONE printed copy of the show order per table. The show order will also be posted in the dressing rooms. Please print your own copy if you need one.

Video and Photographs:

We take an “official” video recording. You may request, on your consent form, that your video not be posted on the chapter’s YouTube channel. You may ask a friend to video your performance from behind our “official” videographer.

If you dance too close to the camera, or too far to the left or right, you will not be in frame. We advise all dancers in a given routine enter & exit at a single side of the floor, so that all dancers can be seen. Your best results will be if you plan your choreography for a 20’ x 30’ (approximately) space and keep toward the stage side of the floor. *Our crew will put down a small tape line to indicate the optimal performance area.*

You are welcome to take posed photographs on the stage behind the curtain.

Spectator Admission:

We will *not* be offering a spectator admission rate for the 2015 Showcase.






