

# **DANCE LINES**

### **COMPETITION MADNESS**

"COUPLE NUMBER 40: GREG MOORE AND JANIS LIVINGSTON..."

Our first competition. I look out across the dance floor, vast and empty. I take a final peek at Janis. She is radiant, glowing with excitement and confidence, a lighthouse on this strange and unforgiving sea. Out there we will be judged: analyzed, categorized, and ranked. And if we screw up, there will be no mercy. We will be chewed up and spat out. What was once a merry, carefree pastime has become

a terrifying test. People with whom we have laughed and cavorted are now dangerous obstacles, elegantly dressed icebergs which we must gracefully avoid at all costs. I suck in my gut, lift Janis' hand high and lead her proudly onto the floor. Inside this dashing tailsuit I am sweating and shaking. Outside, however, I am cold steel. I stride forward, gazing out over the heads of the audience. I smile audaciously, like a condemned man daring the executioner to strike.

How the ding-dong did we get into this predicament? What ever induced us to spend our hard-earned dollars on lessons, costumes, makeup, and entry fees so that we may be allowed to run this gauntlet? How did two sane people drift into such insanity?

When we partnered up there was no talk between us of competition. We were unburdened by plans, goals, or ambitions. Dancing was just fun. For that first year we attended group classes, took an occasional private lesson together, went to the monthly USABDA parties, and thoroughly enjoyed ourselves. It seemed like enough for us. We also heard disturbing stories about the competition ordeals of our fellow students: the expenses, the emotional strain, the heartbreaks. We would shake our heads and chuckle. We're too smart for THAT nonsense, we assured each other. But is was already too late. Inside each of us, crouched in some dark psychic corner, a little demon waited patiently.





Now and then our group class would put together a routine and perform it at one of the monthly studio parties. We were always unsure of our choreography and technique, and there were always little booboo's, but everyone laughed and had a good time. For Janis and me, each performance was a thrill, and we would discuss it for weeks afterward. Then one day, quite innocently, we started talking about performing our own little routine. And the demons began to stir.

What dance should we do? Waltz? Foxtrot? Quickstep? Ever so quietly, the demons began to chant: t-a-n-g-o. So we asked our coach for a tango. He was delighted. What music did we want? he asked us. We didn't know, so he played

about a dozen selections. They all seemed a little ... insipid. Then he played "Jealousy." It was theatrical, melodramatic, unbelievably campy. Janis and I turned to each other in astonishment, as our demons shouted in unison: YES! THAT'S IT!

The coach threw himself into the project, as if driven by his own demon. Now all three of us were caught in this spell. We concocted a sketchy storyline and two characters, complete with names, backgrounds and costumes. The routine was a bold blend of American and Argentine tango, alternating between proud and wanton, tender and belligerent. It was all very new to us. And exquisitely delicious. What we lacked in experience and skill, we had to make up for in raw attitude. For a few hours each week, we became Tango Man and Tango Woman. And our demons were were cheering like Packer fans on Super Bowl Sunday.

What were our studiomates thinking about this pair that was usually so quiet and demure, as we jousted and grappled and glared at each other? Everyone liked the routine, and always came up with the same question: Are you getting ready for a competition? We were always puzzled by this, because we were still poo-pooing the whole "comp" scene. But we were also deeply flattered, because we were rookies who had been mistaken for competitors.

There was no stopping our demons now --- they had total control. We had become performance-junkies. So it was no surprise that performing the tango routine did not satisfy our craving for applause. It only aggravated it. How on earth would we ever manage to support this habit?

# ICE DANCING MEETS BALLROOM DANCING AT THE WORLD FIGURE SKATING CHAMPIONSHIPS

Professional American Smooth dancers, Scott and Amy Anderson were featured speakers and demonstrators at the annual meeting of the International Skating Union Ice Dance Committee held during the World Figure Skating Championships recently in Minneapolis. It was a week of exciting competition as most of the top amateur skaters fresh from the Olympics gathered for this prestigious event. It was also a week of meetings as guidelines for the upcoming skating season were established. The International Skating Union is the governing body which produces and sanctions those events that the amateur figure skaters and ice dancers compete in throughout a "season" with the World Figure Skating Championships as the finale of the season. Shown on television worldwide, the event was held at the Target Center, the same venue that will host the Twin Cities Open DanceSport Competition's Saturday Evenings Professional events and WORLDANCE '98 Benefit produced by Scott and Amy Anderson on July 11th!

Scott and Amy's lecture focused on the Waltz, as it is the chosen dance for the "Original Dance" phase of competition of the Ice Dancers next season. Ice Dance competition is divided into three phases - the "Compulsory Dance" in which all skaters demonstrate the same sequence of patterns to the same piece of music of a ballroom and Latin dance. The dances demonstrated this year were the "Golden Waltz" (or Viennese Waltz as we know it), and the "Silver Samba." This is 20% of the skater's final placement. The second phase of competition is the "Original Dance" in which the skaters demonstrate their interpretation of the same dance (this year, it was the "Jive") with their own music and choreography. This is 30% of their final placement. The "Free Dance" is the final phase in which the skaters can choose any dance to interpret to their own music. This year everything from a dramatic "Carmen", to step danceing from "Riverdance" was interpreted.

In attendance at this annual meeting were the judges, coaches, skaters, and media that cover Ice Dancing from all over the world. Also in attendance was Julius Kaiser who has coached several ice dancers throughout his career. Having been exposed primarily to traditional, International Waltz, the reception was remarkable as they witnessed (many for the first time!) the "American Style" Waltz and Viennese Waltz as demonstrated by Scott and Amy. Those in attendance know the importance of

"marketability" of their sport and understand what brings high ratings to an already large television audience worldwide. They concluded that it is the freedom of creativity of expression to a particular piece of music, while still demonstrating the characteristics of that dance, that makes Ice Dancing so interesting and entertaining to watch and perform. This is no different than what DanceSport is experiencing, except that Ice Dancing is already an Olympic Sport shown to millions of television viewers worldwide, and receives the corporate sponsorship to develop their sport and make their atheletes household names.

One of the highlights of the meeting was when Scott invited Olympic Bronze medallist and World Silver medallist, Marina Anissina of France to join him as he demonstrated various dance positions that are commonly used in American Style Waltz. Marina, with her flowing red hair, and her partner, Gwendal Peizerat danced as "Romeo and Juliet" during their Free Dance Competition.


Scott and Amy discussed the different interpretations of Waltz depending on the music the couples choose. With help from local professionals, Jay Larson and Julie Jacobson, and Scott's Pro/Am partner Kathy Rotter, they demonstrated Waltzes and Viennese Waltzes from various pieces of music from traditional to contemporary. The lecture was taped for use around the world as coaches and skaters prepare their Original Dance for next season. It will be interesting to see how the skaters interpret American Style Waltz on the ice and how the judges score it. Use of music, skirt length and use of the skirt, dance positions - proper and improper were discussed. For Scott and Amy, it was an honor to be asked to be in the company of this widely respected group of current and former Olympic Ice Dance Champions, and to see how their sport works from the inside. Figure Skating and Ice Dancing is going through some of the same changes and conflicts as we see in DanceSport - how to judge, amateur vs. professional, American vs. International, and the list goes on. We can learn a lot from each other's sport; this lecture was one step closer to that.

# ADVICE FROM THE PROS

# I REMEMBER THE PROM BALLROOM

My first experience with ballrooms began in the late forties at the Prom Ballroom which was located just off University Avenue and Dunlap Street, in St. Paul. Dances were held there several times a week at that time. On Friday and Saturday it was a great place for singles to meet and dance.

The Prom was a beautiful ballroom with a huge floor. There were so many lovely ladies to dance with. It was at this time I learned some ladies lie ... They would tell me what a good dancer I was. Like a dummy, I believed them. I learned later, I was a lousy dancer, but, it was still fun. It was dancing at its finest!

### I remember . . .

- . . . the street cars lined up outside at closing time. Many dancers had no other transportation.
- ... the crowds and the elegance of the Prom.
- . . . hearing that jitterbug dancing was not allowed, although later swing dancing was.
- ... hearing Jules Herman band broadcasting from the Prom on a Sunday night.
- ... hearing about the "Jams" where the dancers would form circles on the floor. It was showtime and the best swing dancers would dance in the circles. It could be East Coast, West coast, or Lindy Hop, etc.
- ... crowds standing in front of the stage watching as the big bands played.
- ... when they had the Four Hundred Dance Club. The club had approximately 100 members whose purpose was to come to the Sunday dance class and assist where needed. They were not allowed to dance with each other during the class.
- ... hearing about the Latin dances in the downstairs Arizona Room.
- ... after many years of absence, I returned to the Sunday night dances. Ladies were in long gowns and men in their suits ---very elegant.
- ... watching this one fellow who always danced with two ladies: one lady dancing directly behind the other. And how smooth they were. I was told they were dancing a style called "Slicker Dance" and that there were only two to four patterns they could use when they had contests.
- ... all the beautiful people I met over the years and the friendships I formed.
- ... the first Minnesota Star Ball. It was the first state ballroom competition.
- ... how sad we all were when the Prom closed.



# THE FIRST ANNUAL STAR OF THE NORTH DANCESPORT COMPETITION

# "WE DID IT"

by Janis Livingston

We had only 5 months to plan this baby. Thinking there was not enough time to design and deploy the event, the board actually voted it down on first consideration. But, after a few energetic souls urged more thought on the subject, AND, with promises of keeping the event to a "low-key", one day affair, a vote was re-taken and passed. Immediately a committee was formed to get this wobbly scheme set in motion.

Starting at ground zero, Steve Vespested and several curious USABDA members met to set up the preliminaries. Just what exactly did we need to do? The brainstormed list was more than a page long. It seemed insurmountable. Eventually, though, jobs were casually and voluntarily distributed (most of us did not know exactly what we were supposed to do with our assignments or where we were going with our helpful and expectant energy.) Thanks to some of our USABDA competitors like Jason Borton and Julie Chase we obtained some direction and made decisions based on their experience.

Just like jello beginning to set, we were free flowing liquid... unformed... unknowing what the final product would be. The venue site was discussed --- high school gym or hotel? The floor --- should we rent or even buy one? The registration fees --- could we keep them low enough to encourage registrations? The vendors --- how many and what kind? The judges --- would our local pros be interested in giving up a day of income to help us out? On and on, question after question, we took a stab, made a decision and went with it.

Gradually, through the efforts of all, things started to firm up. The beautiful venue site of the First Trust Center was chosen (no high school gym for us). A floor was possible with corporate sponsorship. Steve produced a budget and we set the fees low. Vendors were recruited and were willing to take a chance. And our wonderful local pros gave us an enthusiastic commitment to judge. The jello was setting.

As March 28, 1998 approached, the firmer that jello became. (By the way, does jello expand ...? Someone must have dropped a little yeast into our concoction because that "low-key" event we all expected was becoming larger and more grandiose by the day.) Our goal of 100 participants was exceeded by over 30. Our modest efforts of putting

on a small competition encouraging newcomers and first time competitors kept multiplying ... becoming 167 heats and over 1000 starts!

To accommodate dozens of late registrations, the schedule was constantly being revised. We didn't want to turn anyone away. We didn't know it then, but ... our jello was about to plop over the sides of the bowl! It wasn't until we got moving into heat after heat that it became apparent that the ever-revised schedule was in a time warp. Our inexperience did not prepare us for this (and a few other glitches). Even after mega-hours of preparation, we could not have foreseen that ultimately we would have to cut out the lunch break and end the competition 2 1/2 hours late!

The beauty of the venue, the excitement in the air, the hopeful anticipation of the participants went a long way to salve the fatigue that had inevitably started to show toward the end of the day. Our Star of the North organizing committee had done a stellar job. Our judges had been asked to pitch in extra hours beyond their already grueling, no break, schedule for the day. And they did it graciously. In the end, despite the worry, the fatigue, the stress, the over stimulation, WE survivors felt good. WE had pulled it off! WE did it! The First Annual Star of the North DanceSport Competition was in the bag. That plopped over jello tasted sooo good!




