Oregon Motorcycle Riders Association is authorized by state law ORS 181.555 and ORS 802.179 to conduct a criminal and/or motor vehicle background check for purposes of qualifying an individual for volunteer service into the OMRA YSEP. Successful completion of a criminal and/or motor vehicle background check is a condition of your association with OMRA YSEP.

In conducting criminal and/or motor vehicle background checks, OMRA may use criminal offender information maintained by the Oregon State Police, the Federal Bureau of Investigation and record resources.

You are entitled to review the criminal and/or motor vehicle history information maintained by the Oregon State Police, the Federal Bureau of Investigation, and the Oregon Department of Motor Vehicles and to challenge information you believe is inaccurate, incomplete, or maintained in violation of any state or federal statute or act. To obtain a copy you must contact the specific agency directly.

You have rights under Title VII of the Civil Rights Act of 1964. If you wish to obtain further information, you must contact the Oregon Bureau of Labor and Industries.

## Certification and Authorization:

I hereby authorize Oregon Motorcycle Riders Association to obtain reference information concerning me and to conduct a criminal and/or motor vehicle background check through law enforcement agencies, court's and records resources. Information of a confidential and privileged nature is included in this authorization. I also understand that a conviction of a crime against a person or property may negatively impact or prevent me from obtaining a volunteer position with OMRA YSEP. I understand that I may be required to submit to fingerprints in order to facilitate the process of the criminal and/or motor vehicle check, and failure to comply with the request will disgualify me from volunteer service within OMRA.

I certify that the information I have provided on this form is complete and truthful. I understand that providing false or misleading information or failing to disclose convictions will be basis for disqualification from consideration for volunteer service with OMRA.

I hereby release and discharge, to the extent permitted by law, OMRA, its Board of Directors, representatives of OMRA, OMRA YSEP committee members and coordinators and any individual or agency obtaining information for OMRA, for any claims known or unknown, damages, losses, liabilities, cost, or other expenses arising from the retrieving, reporting, and/or disclosure of information in connection with this background investigation. OMRA YSEP shall pay the cost of the initial background investigation. I understand that I may appeal to the OMRA board of directors if a decision is made to disqualify me for OMRA YSEP volunteer service based upon the results of my criminal background investigation or motor vehicle background check if I contest that the information revealed by such investigation is incorrect. I have read and fully understand all of the above information.
